



## System for Change

### Instructions

The **System for Change Award** recognizes health systems that are **working cohesively to set system goals, track data, benchmark, and share successes in environmental performance**. Health systems must be comprised of at least **four hospitals**, all of whom must be current PGH partners. A **minimum percentage** of the health system's facilities must also **win recognition** the same year in order for the system to receive this award. This percentage varies by size. If you have a question about your eligibility, see resource below or contact your Member Engagement liaison or **Awards Technical Assistance** via email or at 888-378-2259.

**Table A. Percent of facilities that must win recognition to earn System for Change award**

Number of hospitals in the health system	Percent of facilities that must win recognition
4 - 10 facilities	75%
11 - 25 facilities	60%
26 + facilities	40%

Practice Greenhealth has **adjusted the qualifying thresholds** for the System for Change award in 2021--recognizing that some hospitals typically engaged in the work may be unable to participate due to the pandemic.

A **sub-system** of a larger health system may apply for SFC, but will need to apply the percentage rule to the size of the subsystem (e.g., if the parent system has 30 hospitals, but the subsystem applying for SFC has 10 hospitals, then the sub-system must have 75% of their subsystem's hospital members win the PFC this year).
